BOOKING CONDITIONS

1 THE PROPERTY KNOWN AS **LA BLANCHIE** IS OFFERED FOR HOLIDAY RENTAL SUBJECT TO CONFIRMATION BY **MR & MRS FRAMPTON** (THE OWNERS) TO THE RENTER (THE CLIENT)

2 TO RESERVE THE PROPERTY THE CLIENT SHOULD COMPLETE AND SIGN THE BOOKING FORM AND RETURN IT TOGETHER WITH THE INITIAL NON-REFUNDABLE DEPOSIT OF (25% OF THE TOTAL RENT DUE) FOLLOWING RECEIPT OF THIS THE OWNER WILL SEND CONFIRMATION. THIS IS THE FORMAL ACCEPTANCE OF THE BOOKING.

3 THE CLIENT AGREES TO BE A CONSIDERATE TENANT AND TO TAKE GOOD CARE OF THE PROPERTY AND TO LEAVE IT IN A CLEAN AND TIDY CONDITION AT THE END OF THE RENTAL PERIOD. ALTHOUGH A FINAL CLEAN IS INCLUDED IN OUR PRICES THE OWNER RESERVES THE RIGHT TO MAKE A RETENTION FROM THE SECURITY DEPOSIT TO COVER ANY ADDITIONAL CLEANING COST IF THE CLIENT LEAVES THE PROPERTY IN AN UNACCEPTABLE CONDITION. THE CLIENT ALSO AGREES NOT TO ACT IN ANY WAY WHICH WOULD CAUSE DISTURBANCE TO ANY OTHER RESIDENT STAYING AT LA BLANCHIE

4 THE CLIENT SHALL REPORT TO THE OWNER WITHOUT DELAY ANY DEFECTS BREAKAGES IN THE PROPERTY OR TO ANY MACHINERY THAT OCCURS DURING THEIR RENTAL PERIOD.

5 THE OWNERS SHALL NOT BE LIABLE TO THE CLIENT FOR ANY ACCIDENTS OR LOSS THAT MAY OCCUR (PLEASE MAKE SURE THAT YOU HAVE TAKEN OUT THE APPROPRIATE INSURANCE TO COVER YOU AGAINST THIS SORT OF HOLIDAY)

6 A SECURITY DEPOSIT OF £200 IS REQUIRED FOR THE RENTAL PERIOD IN CASE OF FOR EXAMPLE DAMAGE TO ITS PROPERTY OR CONTENTS. HOWEVER THE SUM RESERVED BY THIS CLAUSE WILL BE RETURNED IN FULL AT THE END OF THE RENTAL PERIOD IF NO SUCH DAMAGES OCCUR

7 PLEASE NOTE DIVING IS NOT PERMITTED AT ANY TIMES IN THE SWIMMING POOL, AND NO ITEMS ARE TO BE PLACED ON THE FENCING OF THE SWIMMING POOL (DUE TO THE FENCING HAVING TO CONFORM TO FRENCH SAFETY STANDARDS AND THE POLES BEING MADE OF FIBREGLASS) ANY DAMAGE TO THE POOL OR THE FENCING WILL BE RETAINED FROM THE SECURITY DEPOSIT.

8 BLEACH MUST NOT BE USED AT ANY TIME (WE HAVE A FOSSE SEPTIQUE AND BLEACH AFFECTS THE WAY IT WORKS)

9 THE RENTAL PERIOD SHALL COMMENCE AT 4.00PM ON THE FIRST DAY AND FINISH AT 10.00AM ON THE LAST DAY. THE OWNER SHOULD NOT BE OBLIGED TO OFFER THE ACCOMMODATION BEFORE THE TIME STATED AND THE CLIENT SHALL NOT BE ENTITLED TO REMAIN IN THE OCCUPATION AFTER THE TIME STATED.

10 ALL BARN AND OUTBUILDINGS ARE STRICTLY PRIVATE PROPERTY AND ARE NOT TO BE ENTERED AT ANY TIMES.

11 PLEASE NOTE THAT THE RENTAL AGREEMENT IS SOLELY FOR THE PAYING GUESTS AT THE TIME OF BOOKING SO THEREFORE DOES NOT ALLOW FOR ANY FRIENDS OR VISITORS THAT MAY EITHER WANT TO RESIDE AT THE PROPERTY OR VISIT. THIS IS STRICTLY DOWN TO THE OWNERS DISCRETION AND MUST BE DISCUSSED BEFORE HAND ONLY PAYING GUESTS ARE ABLE TO USE THE SWIMMING POOL.
